ORDER

In the G.Os. read as first and second papers above Government have prescribed a pro forma for seeking the concurrence of the Public Service Commission for the continuance of provisional (temporary) hands beyond three months. Subsequently, it has been ordered in the G.O. read as third paper above that persons appointed on a provisional (temporary) basis through the Employment Exchange to posts other than teaching posts should not be allowed to continue in such posts for a period exceeding three months. According to the G.O read as 4th paper above person appointed on a provisional (temporary) basis to teaching posts in educational institutions can be allowed to continue, subject to availability of vacancies, till the end of the academic year or till regular Public Service Commission recruits join duty, whichever is earlier.

2. In the letter read as 6th paper above the Public Service Commission has proposed that consequent on the issue of orders in the G.O. read as third and fourth papers above the pro forma prescribed in the G. Os. read as first and second papers above requires modification. The Commission has forwarded a draft pro forma incorporating the required modification. Government are pleased to revise the pro forma prescribed in the G.Os. read as first and second papers above.
