**ORDER**

The following temporary posts created in the various Offices under the Forest Department as indicated below were diverted to the office of the Chief Conservator of Forests as the staff sanctioned for his office were inadequate to cope with the increased volume of work.

- i. One temporary posts of U.D. Clerk from Industrial Plantation Circle Office, Perumbavoor.
- ii. One temporary post of L.D. Clerk from the Assistant Wild Life Preservation Officer's Office, Parambikulam.
- iii. Two temporary posts of L.D. Clerks from Wynad Division.
- iv. Two Temporary posts of L.D. Clerks from the Office of the Assistant Conservator of Forests, Hydel Division, Kottayam.
- v. One temporary post of L.D. Clerk from Malayattoor Division.
- vi. Two temporary posts of peons from Working Plan Officer's Office, Konni (now functioning at Munnar)
- vii. One temporary post of U.D. Clerk from the Assistant Conservator's Office, Pamba.
- viii. One temporary post of L.D. Clerk from Nemmara Division.
- ix. One temporary post of L.D. Clerk from the Assistant Conservator's Office, Teak Plantation Division, Parambikulam.

The Chief Conservator of Forests has reported that consequent on the formation of new Circles and subordinate Officers under them, the work in the Head Office has increased considerabl and that the services of the diverted staff is still essential in order to cope with the increased work. He has therefore proposed that the above temporary post

may be abolished in the office from where these posts have been diverted and an equal number of posts created in his office.

Government have considered the question and are pleased to order the abolition of the above mentioned temporary posts in the offices indicated creating simultaneously an equal number of identical posts in the office of the Chief Conservator of Forests with effect from the date of diversion of these posts.
