## **ORDER**

In the G.O. read as the first paper, Government ordered that the inmates of After Care Homes and Orphanages which are recognised by Government or are receiving grant from Government will be given (i) age concession of ten years over and above the maximum age limits prescribed for direct recruitment posts in the various services of the State (including posts that are outside the purview of the Public Service Commission ) and (ii) priority for appointment through the Employment Exchanges, provided they are otherwise qualified for appointment and are found suitable for the posts notified . As per the G.O. read as the second paper, rescued women and children of Rescue Homes are also eligible for priority in appointment through the Employment Exchanges, provided they are otherwise qualified for appointment and are found suitable for the posts notified

2 Government are now pleased to order that the concessions contemplated in the Government Orders read above viz. age concession and priority for appointment through the Employment Exchanges be extended to the ex-inmates of After Care Homes Orphanages and Rescue Homes also.
