<u>ORDER</u>

Smt. P.O. Jessy, daughter of Shri. P.P. Kochappan, Forest Guard who died on 2-8-1979 while in service, has in her application dated 13-11-1979 requested for appointment in Government Service under the scheme for providing employment assistance to the dependents of Government Servants who die in harness. The Chief Conservator of Forests has in his letter read as 3rd paper above recommended the request of the applicant. The Chief Conservator of Forests has further stated that the deceased Government Servant had a total continuous service of 33 years in the Department. The Thahasildar, Mukundapuram has reported that the annual income of the family of the deceased Government Servant is Rs. 1575/- and the District Collector, Trichur has recommended the request of the applicant.

- 2. Having examined the case in detail Government find that Smt. P.O.Jessy is eligible for the concession of employment assistance under the dying in harness scheme. Government are therefore pleased to accord sanction for the appointment of Smt. P.O. Jessy, Pallippadan House, Near St. Joseph's Church, East Potta, Chalakudy P.O., Trichur District as lower Division Clerk in the Department of Forests.
- 3. The Chief Conservator of Forests will issue necessary orders of appointment to Smt. P.O. Jessy as L.D. Clerk in the Forest Department subject to verification of age, Educational qualifications, Character and antecedents as are necessary in respect of fresh recruits.
