**ORDER**

The Chief Conservator of Forests in his letters read above has stated that a number of review cases on vested Forests are pending with the Forest Tribunals and the High Court of Kerala. The Advocates conducting those cases in the Forests Tribunals and the Senior Government Pleaders conducting Review Cases in the High Court of Kerala often call for a number of old records for the proper conduct of the cases. The Chief Conservator of Forest has therefore recommended that a post of Range officer may be created under the Control of the Divisional Forests Officer Special Division. Palghat with Head Quarters at Ernakulam for liaison work connected with O.P./MFA/RP cases in the office of the Advocate General, Ernakulam and to assist the Senior Government pleaders in the proper conduct of the cases by producing the required records , He has also recommended that four posts of Deputy rangers may be created in the four posts of Deputy Rangers may be created in the four Ranges of palghat Special Division exclusive for the liaison work connected with the conduct of vested Forest cases in the various courts.

Government have examined the issue in detail and are pleased to accord sanction for the creation of one post of Range Officer on Rs. 1050-2000 for the period up to 28-2-1987 under the control of Custodian of Vested Forests, kozhikode with Head quarters at Ernakulam for doing liaison work on Forest cases in the office of the Advocate General, Ernakulam and the assist the senior Government Pleaders in the proper conduct of the cases by producing the required records etc. The expenditure on this account will be met from the budget head of the Vested Forest Circle , Kozhikode for the current year.
