## ORDER NO. E1.2263/87 DT. 22-2-1987

In the order  $2^{nd}$  read above sanction was accorded for the creation of the minimum number of posts of Rangers (Rs. 1050-2000) required to comply with the CMP orders of the Hon. High Court. Govt. have also directed that the Court orders in the CMPs in connected OPs are applicable to the petitioners in the Ops alone. The petitioners in the OPs are numbering 6 (six only)
