#### **NOTIFICATION**

In exercise of the powers conferred by the proviso in Article 369 of the Constitution of India, the Governor of Kerala hereby makes the following amendment in the Kerala Service Rules, namely:-

### **AMENDMENT**

C.S. No. 43/61 dated 7<sup>th</sup> December, 1961.

In Part II of the said rules, in rule 86 the existing Note shall be numbered as Note (1) and the following shall be inserted as Note (2) namely:-

'Note:- The Government have entered into a reciprocal arrangement with the Government of Madras for the payment of traveling allowance and other expenses to offers attending Civil Courts as witnesses in their official capacity, on the basis of Rule 4b of Order XVI of the Code of Civil Procedure 1908, Rule 75 of the Civil Rules of Practice (Travancore-Cochin) and Rule 50 of the Civil Rules of Practice and Circular Orders Volume 1. By the arrangement the officers of this State attending Civil Courts in Madras as witnesses in their official capacity on the basis summons issued by the Courts in that State will be paid travelling allowance etc, under the rules of this State as applicable to them, by this Government. Similarly Government of Madras will meet the traveling allowance etc, of their officers attending Civil Courts of this State as witnesses in their official capacity.
