## **Explanatory Note**

(This note is not part of the amendment, but is intended to indicate its general purpot)

The Payment of Salaries and Allowances Act, 1951 (XIV of 1951) as amended by the Payment of Salaries and Allowances (Amendment) act, 1977 (22 of 1977) extends to the Leader of the Opposition the salaries, allowances, amenities, facilities and other

benefits as are allowed to a Minister. The Leader of the Opposition has, therefore, to be brought within the exceptions contemplated in rule 2 of the Travel by Special Conveyance by Members of the Legislative Assembly Rules, 1974. This notification is intended to achieve the above object.\
