ORDER

Pursuant to the orders contained in the Government Orders read above, Government hereby issue the following notification:

NOTIFICATION

S.R.O. No. 232/80- In exercise of the powers conferred by sub section (1) of section 2 of the Kerala Public Service Act, 1968 (19 of 1968), read with section 3 thereof, the Government hereby make the following amendment to Kerala Service Rules, namely:-

AMENDMENT
C.S. No. 373/80

1.(i) These rules may be called the Kerala Service (Amendment) Rules, 1980.

(ii) They shall be deemed to have come into force with effect from the 1st day of September, 1975.

2. In Part I of the Kerala Service Rules, in Appendix ix for the paragraph specifying the boundary of the Paravattany Range on the West, under the heading "B Class II Tracts" the following shall be substituted, namely:-

"West-Thence the boundary proceeds north-west to reach $\frac{3}{4}$ mile north to Vengapara, thence to north-west to reach Peechi Dam, thence proceeds along the Peechi Right Bank Canal to reach the crossing point at Trichur-Vaniampara road and thence proceeds north-west to meet the inter Taluk boundary at the starting point".
