ALLOWANCES-TRAVELLING ALLOWANCES TO LAST GRADE SERVANTS DEPUTED FOR TREASURY DUTIES-ENHANCEMENT OF ORDERS ISSUED.

## ORDER

In the Government Order read as first paper, an allowance at the rate of Rs. 2 per day has been allowed to the last grade employees deputed for treasury transactions by debit to the contingencies of the Department concerned, when the distance to the treasury from head quarters exceeds 2 kilometres of more but does not exceed 8 kilometres. As per G.O read as second paper, the following clarifications to the above orders were issued to take effect from 15-7-1969.

- (i)The allowance will be paid to such officers who are required under Articles 299 of the Kerala Financial Code Volume I to be engaged for cashing bills or remitting money into the treasuries.
  - (ii) The maximum amount payable for a day will be Rs. 2
- (iii) The allowance will be paid only for journeys to or from the treasury which actually involve the carrying of money, and not otherwise.
- (iv)The allowance will be paid only if no regular Travelling Allowance of other remuneration is payable for the day vide Note under Rule 64, Kerala Service Rules Part II:
- (v)The allowance will be paid only its rates when the office are required to carry Rs. 500 or more, and
- (vi) The allowance will not be paid for more than three visits in a week with reference to a particular office.
- 2.In the circular read as third paper above, the following further clarification were also issued.
- (a)The duty point at the headquarters means the place or office where a Government servant remains on duty; and
- (b) The allowance will be admissible only if the last grade officer is using his own conveyance or engaging one for hire. If Government conveyance is used there is no question of giving any allowance.

- 3.The Association of Class IV employees have demanded enhancement in the present rate of treasury duty allowance Government have examined the matter in detail and are pleased to order that the treasury duty allowance of Rs. 2 sanctioned in the G.O. read as first paper above to last grade employees deputed for treasury duties shall be enhanced to Rs. 5 (Rs. Five only), subject to the other conditions stipulated in paragraphs 1 & 2 above.
  - 4. These orders will have effect from the date of this G.O.
- 5. Necessary amendments to the relevant rules in the Kerala Service Rules will issue separately.
