PENSION-EXTENDING THE BENEFIT OF LIBERALISED PENSION FORMULA TO THE PRE 31-3-1979 PENSIONERS-MODIFIED PROCEDURE-ORDERS ISSUED

ORDER

In the G.O. read as second paper above sanction was accorded for the payment of arrears of pension to pre 31-3-1979 pensioners for the period from 1-4-1979 to 31-3-1984 in the form of National Savings Certificate. It was ordered there in that detailed procedure regarding investment of arrear amount in National Savings Certificate will be issued separately. In the G O red as third paper above orders have been issued prescribing detailed procedure.

2. The Association of the pensioners has requested Government to reconsider the decision and to effect payment in cash. After considering various aspects Government are pleased to issue the following orders in partial modification of the orders contained in the G.O.read as second paper above :-

- i. In the case of those pensioners who have completed 70 years of age as on 1-1-1986 the entire arrear amount will be paid in lump.
- ii. In the case of other living pensioners and death cases the arrear amount will be paid in three installments.
- iii. The payment will commence from March, 1986. The second installment will be paid during the financial year 1986-87. Those who are not able to receive the first installment during March, 1986 can draw the same during 1986-87 along with the second installment. Third installment will be paid during 1987-88.
- iv. To those who cross seventy years of age after 1-1-1986 and more the payment of the second installment the whole balance amount will be paid in lump at the time of the second installment.
- v. The Treasury Officers will fix earliest convenient dates for disbursement of second and third installments now itself and intimate the pensioners.

3. The G.O. read as third paper above stands cancelled. But the ready-reckoned appended along with the G.O. can be used for calculating the arrear amount.
