ORDER

The Kerala State Pensioners comprises of two district group according to the Service rules by which they are governed viz., (i) those are governed by keral Service Rules and (2) those are governed by T.S.R, C.S.R and M.F.R. Those who are governed by the provisions in K.S.R are eligible for Death-cum-retirement Gratuity at the rate of ½ a months pay for every completed year of service subject to a maximum of 33 years in addition to pension according to the liberalized pension rules. Those who are governed by T.S.R, C.S.R and M.F.R are eligible only fro pension at the rate of 50% of the average emoluments ie they are denied of the benefit Death-cum-retirement gratuity, To this extend, these category of pensioners stand to lose . Further the pay structure in early sixties was very low and hence the quantum of pension also is very low. Thus the category of pensioners who are governed by T.S.R , C.S.R and M.F.R in view of the low amount pension as well as the loss on account of intelligibility of Death-cum-retirement Gratuity.

2. After having examined the question in detail Government have come to a decision that is only just to grant these categories of pensioners an allowance to compensate the loss of Death-cum-retirement Gratuity. In the circumstances Government are pleased to sanction an amount an amount of Rs.30 per mensem for those who are drawing minimum pension and Rs, 50 per mensem for other as compensatory allowances (in lieu of Death-cum retirement Gratuity) to the pensioners governed by T.S.R and C.S.R, M.F.R .This amount will not be reckoned for the calculation of D.A on pension.

3. This order will take effect from 1-6-1986 .In the case of a pensioner after 1-6-1986 the arrears of increase will be paid to the legal heirs.
