Sub: Family Pension to the families of Government employees who died or retired before 1-4-1964 or otherwise not covered by the Liberalised Family Pension Scheme-Further clarification-issued.

In the Government Order referred to above the benefit of liberalized family pension scheme was sanctioned to the eligible members of the families of all those Kerala Pensioners who retired before 1-4-1964 and to those who opted out of the scheme. The family pension in such cases is being sanctioned by:

- (i) the Treasury Officers where Pension Payment Order of the retired/dead Officer is available.
- (ii) The Heads of offices/departments in cases were the PPO is not available but service details are available to establish the claim for family pension.
- (iii) The Government in other genuine cases.

It has come to the notice of Government that there are cases where Either the P.P.O or the other service details are not available especially in cases where retirement or death of Government employee took place some 30 or 40 years back. Government after examining the question in detail issue the following further instructions so as to expedite sanctioning of family pension as per the Government Order cited. In cases where P.P. O or details of service are not available collateral evidence obtained from contemporary officers indicating that the husband/wife of the applicant for Family Pension was in pensionable service of Government or certificate to the above effect from Panchayat President, Municipal Chairman, City Corporation or Mayor of the area where the family of the Government Servant was ordinary residing can also be accepted as proof for sanctioning Family Pension by the department officers.
