Sub:- Reappropriation/ Resumption Furnishing reasons for savings excess instructions issued

Ref:- LetterNo.FAA/11/37/2000-01/193 dated 16.2.2001 from the office of the Accountant General (Audit), Kerala.

The Accountant General pointed out that the reasons offered in the footnotes under reappropriation resumption orders are too vague to indicate substantive grounds for the reappropriation resumption since they do not set forth specific factors which caused the savings excess. Since the reasons furnished have to be incorporated in the Appropriation Accounts which are to be examined by the Public Accounts Committee of the Legislature laps on sustained reasons may lead to severe comments from the Committee. It is noticed that certain departments are not furnishing the reasons on clear terms while proposing reappropriation/ resumption. They have not furnished reasons for savings/ excess in spite of repeated reminders from the Accountant General.

ALL HEADS OF DEPARTMENTS/CHIEF CONTROL OFFICERS are again reminded to observe the provision o the Kerala Budget Mannual that reasons furnished along with the proposals for reappropriation/ resumption should be full, frank forthright and specific and not in general terms such as expenditure is less than that anticipated etc. Based on the trend of expenditure provision likely to be in excess should be ensured that case involving savings excess during previous years in respect of which reasons sought by the Accountant General will be furnished to him within the stipulated time.
