ORDER

As per Rule 90 (4A) Part III Kerala Service as modified in G.O (p) No,456/79/Fin.dated 5-5-1979 higher rate of Family Pension is payable for 7 years or up to 62 years Whichever is earlier to the employees who retire at the age of 58. As per Government Order 2nd cited higher rate of Family Pension is payable for 7 years in the case of Last Grade Servants retiring at the age of 60 subject to the condition specified in the G.O. (p) No.456/79/Fin. Dated 5-5-1979. But the above Government Orders are silent on the higher rate of family pension for 7 years in the case of State Government employees including NMR/SLR employees attached to PWD/Irrigation Department etc, who retire at the age of 58 years. As a result they are not eligible for the higher rate of Family Pension beyond the age of 62 years. This is an ambiguity.

Government have examined the matter in detail and are pleased to clarify that the higher rate of family pension will be admissible for 7 years or 65 years age whichever is earlier in the case of those who retire at the age of 58 years subject to the condition specified in G.O. (P) 456/79 Fin. Dated 5-5-1979.

This order takes effect from 30-6-1980 as in the case of Government Order cited 2nd above.
