ORDER

In the Order 1st cited Government have permitted those employees who were in service prior to 1-9-1984 to join Group Insurance Scheme with permission to all subscribers to tale more than one units, if required, subject to the condition that the deduction should be effected at full rate in the salary of September, 1995 itself.

- 2. In the letter second cited, the Director of Insurance has reported that due to early disbursement of salary and delay occurred in getting printed copies of orders, most of the employees could not join the scheme in September, 1995 itself. There fore, he has proposed to extend the time limit to March, 1996.
- 3. Government after examining the proposal in detail are pleased to order that the time limit prescribed in the G.O. cited to join the Group Insurance Scheme is extended from September, 1995 to March, 1996. The first instalment of subscription, in respect of those wish to join the Scheme or to take more units, should be effected at full rate from the salary of March, 1996 to be cashed in the month of April, 1996.
