ORDER

Presently the territorial jurisdiction of the entire district of Kasargod is with the DFO, Kannur. Those who have to be in constant touch with the Divisional Forest Office, for various reasons such as claim for compensation for the damages caused by the wild animal, request for No Office of Certificate from the Forest Department for various purposes etc have been demanding for creation of an exclusive division for Kasargod district. The biodiversity richness of the forests of the district also warrant a close monitoring of their administration and protection.

Accordingly the APCCF (Administration) submitted a proposal for establishing a separate division for Kasargod District with Kasargod as Head Quarters by redeployment of staff from various offices of the Forest Department.

Government have examined the proposal in detail and are pleased to accord administrative sanction for the establishment of a new Forest Division Office with Kasangod as Headquarters by redeployment of the staff from various offices of the Forest Department as follows:
