ORDER

The Planning Commission and the State Planning Board have expressed concern over the low level of user charges/fees realized for various of services rendered by Government Department and recommended to introduce/enhance reasonable rates for the services by Government.

2. Government have examined the matter in detail and are pleased to revise the existing rates of fees/charges realised for various services/facilities rendered by the Department of Police with effect from 15 - 7 - 1999, as detailed below:--
