NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India the Governor of Kerala hereby makes the following further amendments to the Kerala Civil Services (Classification, Control and Appeal) Rules, 1957 published in the Gazette No 15 dated the 9th April, 1957, namely:-

In the said rules:-

- 1. After Rule, 11 the following shall be inserted as Rule 11 A namely:-
- 11-A. Notwithstanding anything contained in rule, 11, any of the penalties specified in column 2, of the appendix to these rules may be imposed on the holders of the posts mentioned in column 1, by the authorities specified in the corresponding entry in column 3 thereof'.
 - 2. The following proviso shall be added to rule 21 namely:-
- "Provided that a member holding any of the posts mentioned in column 1 of the appendix to these Rules shall be entitled to appeal to the authority mentioned in the corresponding entry in column 4 against the orders passed by the authority mentioned in column 3 thereof".
 - 3. After Schedule II, the following shall be added as an appendix, namely:-
