## ADVANCES-HOUSING BUILDING TO GOVERNMENT SERVANTS-ADDITIONAL ADVANCE TO THOSE WHO TOOK LOAN IN 1976-77 - ORDERS ISSUED

## **ORDERS**

The maximum amount of house building advance sanctioned to an officer (on joint salary basis) during he year 1976-1977 was Rs.15000. During the current financial year/ the maximum ceiling on house building advance has been fixed as Rs.30000.Instances have come to the notice of Government where the officers who were eligible for more than Rs15000 last year but could get only Rs.15000 because of the ceiling limit are really in need of additional funds to complete the construction o their houses according to the original plan and estimate.

- 2 Accordingly, Government are pleased to order that officers who were sanctioned house building advance in 1976-77 and who were eligible for more than Rs. 15000 under the rules may apply for an additional advance under1 (a) of Section D of Article244 C, Kerala Financial Code, Volume 1.t The quantum of additional loan that may be granted will be the difference between 42 months basic pay (calculated at the time of sanctioning the original loan) or Rs.30000 whichever is less and Rs.15000 already drawn.
- 3. Those who have already drawn an additional advance admissible underRule1(b) of section D Of Article 244 C of the Kerala Financial Code, quantum of additional loan will be limited to the difference between 42 months pay orRs.30000 whichever is less and the total loan already taken, ie, original loan plus additional loan.
- 4. Those who have not taken the additional loan under Rule 1 (b)of Section D OF article244 C/ Kerala Financial Code can apply for an additional loan under that rule or in accordance with the above orders whichever is more beneficial to them
- 5. Grant of additional loan in accordance with these orders will be subject to all the conditions laid down in Rule1 (a)or Rule (b), as the case may be, section of Article244 C, Kerala Financial Code
- 6. Those who desire to avail themselves of the benefit of these orders may apply for the additional advances in Form No30 Kerala Financial Code with the certificate from the PW D Officer as required under the rules.
- 7. The heads of departments will forward the applications from their subordinates (Non-gazettd officers) to the Finance Department direct. Gazetted officers will forward their applications to the Finance department through the Account General.
