Forest & Wildlife Department - Extraction of timber from the Wayanad Colonisation Scheme land - Enhancement of compensation to the farmers and the departmental extraction of balance quantity of timber and firewood - sanction accorded -Orders Issued.

ORDER

As per Government Order read as 1st paper above orders were issued for payment of compensation of Rs. 4500/- per cum to the land holders for the timber extracted from the property of each land holders under the Wayanad Colonisation Scheme land. This was revised to Rs. 5400/- per cum vide Government Order read as 2nd paper above. But the farmers have not accepted the above rate and demanded for a hike in the compensation which resulted in a stand-still in the extraction of timber from Wayanad Colonisation Scheme land. Also, various representations have been received by Government for reconsidering the above Government Orders and to revise the compensation from the already enhanced rate of Rs. 5400/- per cum.

In the Government Order read as 3rd paper above, Government have accorded sanction for departmental extraction of the balance quantity of timber and firewood from the Wayanad Colonisation Scheme land at basic rate or actual expenditure, whichever is less, as against the proposed 109% above the basic rate minus contractors profit. As per letter read as 4th paper above, Chief Conservator of Forests (P) has proposed to allow the department to do the work departmentally at 109% above the basic rate less contractor's profit which according to him is the minimum actual rate required for the execution of the work as the actual expenditure would be 109% above the basic rate less contractor's profit.

Government have examined the matter in detail and are pleased to order as follows.

- (i) The compensation for timber extracted from existing Rs. 5,400/- per cum to the land holders of Wayanad Colonisation Scheme land will be enhanced from the existing Rs. 5400/- per cum to Rs. 10,000/- per cum. The expenditure on payment of compensation will be met by debiting to the Head of Account '2406 - 01 - 105 - Forest Produce - 99 - Timber and other produces removed by Government Agency (NP)'; and
- (ii) Sanction is also accorded to the department to do the work of extraction of timber from Wayanad Colonisation Scheme land departmentally at 109% above the basic rate less contractors profit.


