1.As per G.O (P) 522/65/Agri, dated 14-7-65, Government ordered the supply of timber free of cost to the disabled ex- servicemen or other dependent limiting the value as Rs. 250/- at the market rate, in each case.

2. The Chief Conservator of forests in his letters read above has reported that it is difficult to fix up the market rate of timber for a particular period for arriving at the amount of Rs.250/- as instructed in rule 2 of Appendix to the above order. He has also requested that the full value of the timber supplied may be adjusted towards Forest revenue let the normal forest revenue be affected.

3. The Controller of Accounts in his letter read as third paper above, has

suggested that the average rate of the three sanctions may be taken as the market rate provided that rate is the same as that usually adopted for the supply of timber to of other Departments of government, and that the value of timber supplied to each granted may be credited to 'LI forest (b) timber and other produce removed from the forest by consumers or purchasers (i) Timber by per contra debit to "Items Adjustable by Civil" in the Divisional accounts specified in the G.O dated 14-9-65.

4. The Chief Conservator of forests in his letter dated 28-7-67 has suggested that the average rate for the three previous auction sales may be made applicable as the market rate whether it is above or below the schedule rates since the average rate of the three past auction and the schedule rate need not be the same, and that accruing the suggestions of the Accountant General cannot be implemented. 5. Government are pleased to accept the suggestions of the chief conservator of forests in Para 4 above.

6. Sanction is also accorded to credit the value of the timber as suggested by The Accountant General.
