NOTIFICATION

S.R.O. No. 125/78 – In exercise of the powers conferred by article 318 of the Constitution of India, the Governor of Kerala hereby makes the following amendments to the Kerala Public Service Commission (Composition and Conditions of Service of Members and Staff) Regulations, 1957, namely:-

AMENDMENT

In the said regulations-

- (1) after regulation 6D, the regulation shall be inserted, namely:-
- "6E. The Chairman or other member of the Commission who on the date of entering on his duties as such, was in the service of the Government of India or the Government of a State, shall be granted the following concessions, namely:-
- (a) Conveyance allowance of Rs. 150 per mensem provided a car is maintained.
- (b) House rent allowance at the rate of 10% of pay whether the person owns a hose at the headquarters or not."
- (c) (2) for regulation 7 the following regulation shall be substituted, namely:-
- "7. The Chairman and a member of the Commission appointed as such from outside Government service shall on retirement after completion of six years' service, be paid pension at a fixed rate of Rs. 562.50 and Rs. 450.00 respectively:

Provided that such a Chairman or a member of the commission who has retired from service of the Commission before the Ist day of April 1974 on completion of six years' service the amount of pension shall be on-fourth the actual amount of slary drawn by him at the time of retirement.";

- (3) in sub-regulation(1) of regulation9,-
- (i) the following shall be inserted at the end namely:"and a special pay at Rs. 150 per mensum".
- (ii) in the proviso, for the words" or the salary mentioned in the clause", the words" or the salary and special pay mentioned in the clause shall be substituted:

Amendment (1) and (3) shall be deemed to have come into force with effect on and from the 9th March, 1977 and amendment (2) shall be deemed to have come into force with effect on and from the Ist March, 1977.

Explanatory Note

(This note is not part of the notification, but is intended to indicate its general purport).

In G.O. Ms. No. 86/77/GAD dated 9-3-1977, read with G.O. Ms. No.209/77/GAD dated 27-6-1977, executive orders were issued granting:

- (i) Pension, with effect from 1-3-1977 to the non--official appointed as Chair man/ Members of the Kerala Public Service Commission who retire/ who have already retired on completion of six years service, at the rate of one-fourth of the actual amount of salary at the time of retirement.
- (ii) Conveyance allowance at the rate of Rs. 150 per mensem to the official Chairman/members of the Commission, provided car is maintained;
- (iii) H.R.A. at the rate of 10% of pay to the official Chairman Members of the commission whether the person owns a house at the headquarters or not;
- (iv) A special pay at the rate of Rs. 150 p.m. to the secretary, Kerala Public Service Commission.

It is considered that the above orders should be given statutory validity by incorporation in the Kerala Public Service Commission (Composition and Condition of Service of Members and Staff) Regulations, 1957. The notification is intended to achieve the above object
