**ORDER**

The Superintendent of Government Presses will publish the following notification in the next issue of the Gazette.

**NOTIFICATION**

S R O No in exercise of the powers conferred by Sub Sections of the Kerala Public Services act,1968 (19 of 1968 read with Section 3 there of, the government of Kerala here by make the following amendment to the Special Rules in respect of the Kerala Forest Subordinate Service, issued in G O 682/62, Public (Rules) Department, dated the 20<sup>th</sup> November 1962 and published in part 1 of the Kerala Gazette NO.1 dated the 1<sup>st</sup>,January,1962.

**AMENDMENT**

In the said rules, in rule2 Class1. category 4 , for the item Forest Guards II Grade and the entries against it, the following category and the corresponding entry shall be substituted, namely;-

Forest Guards 1. Recruitment by transfer from peons who have put in in five years service in the Forest Department.

2.Recruitment by transfer from Watchers, Lascars and Maistries and other last grade servants except peons in the regular establishment of the Forest Department.

3.Direct recruitment from Watchers, Lascars and Maistries belonging to the Work Establishment on the Forest Department.

4. Direct Recruitment from the open market.

Note; 1. Not more than 10% of the vacancies shall be filled or reserved to be filled by the transfer of peons employed in the Department and not more than 10 % by recruitment by transfer of a watchers Lascars and Maistries in the regular establishment of the Department and not more than 5 % by direct recruitment from among Watchers, and Ministries in the Work Establishment till the last incumbent is absorbed in the Department.

1<sup>st</sup> vacancy- 3<sup>rd</sup> method- Work Establishment personal.

2<sup>nd</sup> to 16<sup>th</sup> turns- Open market candidates.

17<sup>th</sup> vacancy- 3<sup>rd</sup>method – Work Establishment personnel.

18<sup>th</sup> to 32<sup>nd</sup> turns-open market candidates.

33<sup>rd</sup> vacancy-3<sup>rd</sup> method-work Establishments personal  
34<sup>th</sup> to 48<sup>th</sup> vacancy –open market candidates.  
49<sup>th</sup> vacancy -3<sup>rd</sup> method –work Establishment personnel.  
50<sup>th</sup> to 64<sup>th</sup> vacancy –open market candidates.  
65<sup>th</sup> vacancy -3<sup>rd</sup> method –work Establishment personal.  
66<sup>th</sup> to 80<sup>th</sup> vacancy-open market candidates.

3. If candidates are not available in any of the methods such vacancies shall be filled up by directed recruitment.

#### EXPLANATORY NOTE:

(This note is not part of the rules of this amendment but is intended to indicate its general purport)

In G.O.MS.336/68/April,dated-4-7-1968 it was ordered that work establishment employees of the Forest Department who have been continuously in service from dates prior to 1-4-1955 would be absorbed into the regular establishment, if they did not open to continue in the work establishment that their posts would be converted into regular establishment posts and that in future Department. As a majority of work establishment employee would that be absorbed into the regular establishment Government have decided XXI that out of the 154 vacancies of forest guards reserved for being filled up by director recruitment of Watchers, Lascars and Maistries etc..10% may be filled up by transfer of Maistries. Watchers and Lascars etc who being to the regular establishment of the department and the remaining 5 % may be filled up by directed recruitment of who remain in the work establishment. The amendment is intended to achieve the above subject.
