**NOTIFICATION**

S.R.O. No. 1094/84- In exercise powers conferred by subsection (1) 2 of the Kerala Public Services Act. 1968 (19 of 1968), the Government of Kerala hereby make the following amendment to the Special rules for the Kerala Part-time Contingent Service Published under Notification G.O. (P) No. 152/75/PD. Dated 2<sup>nd</sup> August, 1975 as S.R.O. No 742/75, in Part I of the Kerala Gazette No. 34 dated the 2<sup>nd</sup> September, 1975, as subsequently amended, namely:-

**AMENDMENTS**

In the said rules, in rule 3,-

(i) In the second proviso for the words” Provided that” the words a “Provided further that” shall be substituted:

(ii) After the second proviso, the following proviso shall be inserted, namely:-

“Provided also that this rule shall not apply in the case of appointment of part-time contingent employees, who were on fixed contingent charges without posts according to the orders in force prior to the issue of these special Rules and were continuing as such on the 3<sup>rd</sup> November, 1980, to the newly created part-time contingent posts as ordered in G.O. (P) No. 831/80 (253) Fin. dated the 3<sup>rd</sup> November, 1980.”

Clause (ii) of these amendments shall be deemed to have come into force with effect from the 3<sup>rd</sup> November, 1980.

**Explanatory Note**

(This note does not form part of the notification, but is intended to indicate general purport).

According to the Special Rules for the Kerala part time contingent Service, the method of appointment to the various categories in the Service shall be through Employment Exchange except in the case of Ex-home Guard Volunteers and relatives or dependents of Government Servants dying in harness In G.O. (P) No. 831/80/253/ Fin. dated 3.11.1980, it was ordered that in all cases where fixed contingent charges were being paid without posts, the Heads of Departments should make steps to obtain Government sanction creating part-time contingent posts and the existing amendment to the Special Rules for the Kerala Part-time Contingent Service regarding method of

appointment in order to regularize the appointment of the part-time contingent employees, who were appointed before the issue of the Special Rules according to the orders then in force on fixed contingent charges, against the posts created after-3.11.1980. This notification is intended to achieve the above purpose.
