East: Thence the above road for about 4 Kilometers to reach the northern boundary of Class I area at Pulayampara described in the Nellimapathy Range under the heading "A. Class I Tracts".

South: Thence the boundary proceeds along the northern boundary of Class I ara in Nelliampathy Range and reaches the starting point".

Explanatory Note

(This is not part of the notification, but is intended ti indicate its General purport).

By G.O. (P) 852/70/Fin. dated 9.12.1970, Idukki and Vazhathope areas in Thodupuzha Taluk have been declared as Class I Hilly Tract. The Secretary, Board of Revenue was requested to examine this question also along with the proposal for realignment of the Hilly Tracts. Accordingly the Board of Revenue has proposed certain changes to the list of hill tracts in the Kerala Service Rules, by excluding certain area and by including some new areas without any change to the existing boundaries of Kottayam, Kozhikode, Cannanore, Quilon and Trivandrum Districts.

Government have accepted the proposal of the Board of Revenue and this amendment is issued to codify the above changes.
