**S.R.O. No. 149.80.** In exercise of the powers conferred by the proviso to clause (3) of article 320 of the Constitution of India, the Governor of Kerala hereby makes the following amendments to the Kerala Public Service Commission ( Consultation) regulation 1957, namely:-

**AMENDMENT**

1. Short title and commencement- (1) These Regulations may be called the Kerala Public Service Commission( Consultation) Amendment regulations,198 0  
(2) They shall come into force at once.
2. Amendment of the Regulations-In the Annexure to the Kerala Public Service Commission (Consultation) Regulation, 1957,
  - (i) under the heading” State Service”, for item I, the following item shall be substituted, namely:-

“1. All posts in the Governor’s Secretariat and Governor’s House hold”;
  - (ii) under the heading “Subordinate Service, for item I the following item shall be substituted, namely:-

“1. All posts in the Governor’s Secretariat and Governor’s Household”.

**Explanatory Note**

(This note does not form part of the notification but is intended indicate its general purport)

According to the Annexure to the Kerala Public Service Commission (Consultation) Regulations, 1957 the posts of Secretary to Government Governor’s Secretariat and Comptroller, Governor’s Household as well staff in their offices are specifically excluded form the purview of the Public Service Commission. However, it has since been decided that all the posts in the State and Subordinate Services of the governor’s secretariat and Governor’s Household be excluded form the purview of the Kerala Public Service Commission. The Kerala Public Service Commission (Consultation) regulationa, 1957 has therefore to be amended accordingly. The notification is intended to achieve the above object.
