S R O No.54/76 – In exercise of the powers conferred by subsection (1) of section of 2 of the Kerala Public Services Act,1968(19of 1968) read with section 3 thereof the Government of Kerala hereby make the following amendment to the Kerala State and Subordinate Services Rules,1958, namely;-

AMENDMENT

In part II of the Said Rules, in rule 27, after the second proviso to sub-rule (c)before the note,the following proviso shall be inserted, namely;-

“Provided also that where the date of effective advice in respect of a person appointed otherwise than in pursuance of rule17 A and a person appointed in pursuance of rule 17 A is the same, the former shall subject to the provisions in the first proviso be treated as senior to the latter.”

Explanatory Note

(This note is not part of the notification but is intended to indicate its general purport)

It has been brought to the notice of Government that the General rules do not contain any provision to determine the seniority between persons appointed by direct recruitment on the advice of commission and those appointed by Special Recruitment among Scheduled Castes and Scheduled Tribes under General Rule17 of a on the advice of the Commission whose date of effective advice is the same. Government on the advice of the Kerala Public Service Commission have decided that on the analogy of the provisions contained in thesecond proviso to General Rule 17 A on the advice of the Commission whose date of effective is the same. Government on the advice of the Kerala Public Service Commission have decided that on theanalogy of the provisions contained in the second proviso to General Rule27 (c) when fixing the seniority of persons recruited purely on the basis of merit and those recruited by special recruitment, the latter category may be treated as junior to the former category, as the date of effective advice falls on the same date. This notification is intended to achieve the above object.
