AMENDMENT

In Part II of the said rules, in rule 13, the following proviso shall be inserted, namely:-

"Provided that in the case of the ministerial staff of the different departments/offices in the Kerala Ministerial subordinate service the prescribed in G.O.(P) No. 22/63/PD dated the 14th January 1963 as sequent amended certified shall be applicable until the special for the Kerala Ministerial substance service come into force.

This amendment shall be deemed to have come into force with effect from 14th January, 1963."

Explanatory Note

(This note is not part of the notification but is intended to indicate its general purport).

In G.O. (P) No. 22/PD dated 14-1-1963 Government have prescribed the unified tests in office procedure and Account Test (Lower) for the ministerial staff of the different offices of the State Government. The Lower Division Clerks in the Revenue Department allotted from Madras who were governed by the statutory provisions of the

Madras Ministerial Service Rules, would not be bound by the above executive orders which cannot over ride statutory provisions. In this position is accepted a number of orders relating to temporary exemption given to allotted officers belonging to scheduled Cases/Scheduled Tribes will have to be canceled and promotion given by virtue of these orders, reviewed. This will create administrative difficulties. To overcome these difficulties these difficulties it is proposed to give statutory validity to G.O. (P) No. 22/PD dated 14-1-1966, with effect from the date of issue of the order. This notification is intended to achieve the above abject.
