NOTIFICATION

S R O No .866/76-In exercise of the powers conferred by sub section (1) OF SECTION 2 OF THE Kerala Public Services Act 1968, (Act 19 of 1968) read with section 3 thereof, the Government of Kerala hereby make the make the following amendment to the Kerala State and Sub ordinate Services Rules, 1958, namely :-

AMENDMENT

In part II of the said Rules, in sub-rule (c) of rule 27, after the fourth proviso, the following further proviso shall be inserted, namely:

Provided also that the seniority of –

- i. Persons advised by the Public Service Commission for appointment at Assistant Surgeons other than Dental ‘surgeons in the Health Services Department after 14/05/1963 and before the issue of G O (P) No. 255/Public (SS) Department dated 02/03/1963.
- ii. Persons advised for appointment as Dental Surgeons, Graduate Nurses and other para-medical personnel after 14/05/1963 and before 31/03/1965 and
- iii. Persons advised for appointment as Tutors and Demonstration in the 3 Medical Colleges after 07/12/1963 and before the issue of G O (P) 255/Public (SS) Department dated 02/03/1965, excepting those advised in the specialties of Anesthesiology and Radiology in the context of the National Emergency shall notwithstanding anything contained in any judgment decree or order of any court , be determined as follows:-
 - (a) Persons selected by the concerned Defense Selection Board to serve in the Defense Force of India from among those candidate advised by the Public Service Commission from a particular advise list shall be placed in list “A “ and those not selected in list ‘B’. The candidates included in list “a” shall be senior to those included in list ‘B” shall be done in accordance with the inter seniority of the candidates as fixed in the other in which their names are arranged in the relevant advice letters of the Commission and in accordance with the date of earliest effective advice :

- (b) Women Candidates advised for appointment to the posts of Assistant Surgeons Tutors and Demonstrations from the ranked lists prepared after 04/08/1961 and who did not express their willingness to serve in the Defense Forces shall be placed in list "C" the candidates included in list C shall be junior to those on list B. the inters-seniority of persons included in lists "C" shall fixed accordance with the date of earliest effective advice.

Explanatory Note

(This is not part of the notification but is intended to indicate to general purport.)

In the context of national emergency Government issued orders is G O (MS) No. 357/63/Health dated 14/05/1963 G O (M S) No 556/64/Health dated 04/08/1964 for recruitment during 1963-647 and 1964 -65 of Assistant Surgeons Tutors and Demonstrators in Medical Colleges (excepting those in the specialties of Anesthesiology and Radiology) Dental Surgeons in the Health Services Department, Graduate Nurses and other para-medical personnel with the specific condition for secondment to defense services . According to the orders, in the matter of recruitment the candidates who expressed their willingness to serve in the defense forces at the time of recruitment and subsequently found fit by the Defense Selection Board , were placed in list "A" and those not selected in list "B" . These candidates in list "A" would be seniors to those in list "B". The candidates who did not express their willingness to serve in the Defense forces were to be placed in list :C: The Candidates in list "C: would be juniors to those in list "B'

2. In G O (P) No 255/PD dated 02/03/1965 Government modified the conditions laid down in the above orders in respect of recruitment of Medical Graduates making them liable to serve for a minimum period of 4 years in Defence services if so required, So the A B C classification has been removed with effect from 02/01/1965 in the case if medical graduates. For others this classification is applicable in respect of those recruited till the end of 1964-65 (ie till 31/03/1965)

3. The seniority of medical personnel recruited during the period 1963-64 to 1964-65 is to be determined in accordance with the orders of Health Department mentioned above. This amendment is intended in achieve the above object.
