Sub:- A.I.S. – Employment of members of family of – members of All India Services in foreign organisations-  
Instructions.

I am directed to state the Government of India have issued revised instruction, in super session of the earlier instructions, regulating the employment of member of family of all India Service officers in foreign organizations in India. The relevant instructions are given below for information and guidance. Under the revised instructions member of the family of an AIS shall not accept e

employment in any of the following categories of foreign organizations in India except with the prior permission of the Government of India.

- (i) Foreign missions and related organizations like united States International Communication Agency, British Council, Cooperative for American Relief Everywhere, Catholic Relief Services etc.
- (ii) International organizations, namely U.N. and other related organizations or any other similar body of which India is a member.
- (III) Foreign commercial organization is defined as follows:-  
Section 521 of the Companies Act, 1956, and also includes;-
  - (a) A company which is a subsidiary of foreign company, and
  - (b) A multi-national corporation within the meaning of the Companies Act,
    - (i) A corporation not being a Foreign company, in comported in a foreign country or territory;
    - (ii) A Multi- national corporation within the meaning of the Foreign Contribution (regulation) Act, 1975.
  - (iv) A Company within the meaning of the Companies Act 1956 if more than one- half of the normal value of its shore capital is held, either in the aggregate by one or more of the following namely:-
    - (a) Government of Foreign country or territory,
    - (b) Citizens of a foreign country or territory,
    - (c) Corporations incorporated in a foreign country or territory,
    - (d) Trusts, societies or other associations of individuals (whether incorporated or not),formed or registered in a foreign country or territory.

In the case of employment by a member of the family, other than the spouse, of the member of the service in an international organization with which the Department in which the member of the Service concerned is working is not connected officially, prior intimation to the Government of India will suffice.

Member of family for this purpose would include:-

- (a) The spouse, but not including a separated spouse or one living separately while judicial separation proceedings are on:
- (b) Children and step-children but not including children and step-children of whose custody the Government servant has been deprived of by law. This should normally include all minor children and also adult children living as dependents with the Government Servant
- (c) other persons such as those who are dependent on and normally live with the Government Servant.
