**ORDER**

In supersession of the Government orders read above, Government order that the Programme appended here to will be followed for the training of IAS probationers in this State Commencing with the training of IAS probationers in this State Commencing with the 1982 batch of probationers who reports to this State for training.

Immediately after arrival at the State Headquarter after their first lap of training at the Lal Bahadur Shastr National Academy of Administration, Mussorrie, the IAS probationers will call on the Special Secretary, General Administration Department Revenue Secretary, First Member, Board of Revenue and Chief Secretary, Three days at the /state Headquarters will be allowed for this purpose. Thereafter the probationers will be attached to the Institute of Management in Government, Trivandrum, for two weeks, as per item I of the Programme appended, before proceeding to their respective Districts for under going the other items of the training in the Districts, Prescribed in items 2 tp 360. They will again report to the State Headquarters to under go the training prescribed in items 31 to 35, after which then probationers will go back to their Districts form where they will be relieved for the second phase of their professional training at the Lal Bahadur Shastri National Academy of Administration, Mussoorie.

3. During the entire period of training till they are relieved for their second lap of training at the Academy, the probationers will be attached to their respective District headquarters for purpose of Traveling Allowance, Daily Allowance etc.
