ORDER

At Present has IAS Officers have to pass a test in Finance and Accounts matters as part of the Departmental examination for Junior members of the service for getting promotion to the senior time scale. Likewise the IFS officers have to pass the Account Test (Lower). Ips Officers do not have any test in Finance

Account Test matters. Government considers that IPS Officers should also be familiar with the rules in Finance and Account matters for the effective functioning of their offices.

2. Accordingly Government prescribed the following test, viz. Unified Accounts test for all India Service Officers to the Junior members of IPS and IFS also and they will be qualified to set promotion to the senior time scale only if they pass this test also. The test will consist of one paper of 3 hour duration on the following books.

1. Kerala Financial Code 2 volumes
2. Kerala Trasury Code 2 volumes with books.
3. Kerala Budget Manual
4. Kerala Services Rules.

(This paper is now as conducted Division _ B in Higher standard test for the IAS Officers.)

In respect of IPS Officers, the test will be obligatory promotion to the senior scale commencing form officers of 1981 batch.

For IFS Officers this will be in the place of the existing Account test Lower. These who have already passed Account Test) Lower) need not pass this test again.

The Director General & Inspector General of Police and Chief Conservator of Forests are requested to bring this to notice of all officers concerne.
