ORDER

In the G.Os read as Ist 2nd papers above recruitment ministerial posts etc., has been ordered to be made district-wise subject to the conditions mentioned therein. One of the conditions is that the persons recruited district- wise will not be given transfer from one district to another within a period of five years form the date of commencement of continuous service. In the G.O. read as third paper above Government have ordered that in the case of candidates appointed as L.D. Clerks under the scheme for giving employment to relatives/ dependants of Government Servants dying in harness, they will be given at the time of appointment an opportunity to opt to any unit of their choice if such an appointment is made to posts coming under the unit system and that if they cannot be appointed to the units they opted initially, they will be transferred to the units of their choice at the earliest possible opportunity without losing their seniority. In the G.O. read as fourth paper above it has been ordered among other things that the five year rule prescribed in the G.O. read as first paper above for inter-district transfer of district-wise recruits will be made applicable to persons appointed under the dying in harness scheme against posts which come within the ambit of the G.Os. read as 1st and 2nd papers above. In the letter read as fifth paper above the Inspector General of Police has requested for clarification whether the 5 year rule for inter-district transfer should be observed in then cases of an L.D. Clerk who entered service under the dying in harness scheme before he is posted in the district opted by him or only after that.

Government are pleased to clarify that the orders in G.O. 72/78/Pd dated 3.3.1976 will come into operation in the case of person appointed as L.D. Clerk under the dying in harness scheme only after the candidate is posted to the unit to which he has option in accordance with the orders in G.O. (P) 116/74/PD dated 9.5.1974.
