NOTIFICATION

S.R.O. No 74/78- In exercise of the powers conferred by subsection (1) of section 2 of the Kerala public service act 1968 (19 of 1968), read with section 3 thereof the government of Kerala hereby make the following amendments to the Kerala state and subordinate services rules.

AMENDMENTS

In part II of the said rules in rule 9 in clause(i) of sub rules(a)-

- (1) the note under the second provision shall be omitted;
- (2) for the third provision the following shall be submitted namely;

“Provided also that a persons appointed under this clause by direct recruitment to a teaching post shall be allowed to continue subject to availability of vacancy;

- (a) in case in the institution is one to which regular annual vacation are allowed till the closing date of the institution for the annual vacation;
- (b) in case the institution is one to which regular annual vacations are not allowed for a period not exceeding one year;

OR

till a candidate advised by the public service commission joins duty whichever is earlier.

Explanation: for the purpose of this provision any of the following institutions under the departments of technical education shall be deemed to be an institution to which regular annual vacations are not allowed namely;

- (1) Tailoring and garment making training centers
- (2) Tailoring trade schools and
- (3) Vocational training centers

Explanatory Note

(This note is not part of the amendment but is intended to indicate its general purport).

According to the note under the second provision to rule 9 (a) (i) of the kerala state and subordinate service rules 1958 the term “teaching post” has been defined as a teaching post in educational institutions which have regular authorized vacations. The third provision to the above rules stipulates that a persons appointed under the said rule by direct recruitment to a teaching post shall be allowed to continue subject to availability of vacancies till the end of the academic year or till regular public service commission recruits join duty whichever is earlier. It is considered that persons appointed the teaching posts in the tailoring and garment making training centre tailoring trade school and vocational training centre under department of technical education which have no authorized vacation where the duration of the course of study extends for a period of one year shall also be allowed similar relaxation so that teaching work in these institutions do not suffer interruption due to non availability of teachers.

This notification is intended to achieve the above object.
