NOTIFICATION

S.R.O No 578/77- In exercise of the powers conferred by subsection (1) of the Kerala Public Services Act,1968 (19of 1968). Read with section 3 thereof the Government of kerala hereby makes the following amendments to the kerala state and subordinate service rules 1958, namely:-

AMENDMENT

In part II of the said rules ,in sub rule(a) of rule 9, (1) in clause(i), after the second provision of the following provision shall be inserted, namely:-

“Provided also that no person who does not possess the qualifications if any prescribed for the said service class or category, shall ordinarily be appointed under this clause. Every person who does not possess such qualifications and who has been or it is appointed under this clause shall be replaced as soon as possible by appointing a person possessing such qualifications.”

(2) in clause (iii), the words whether or not he possess the qualifications prescribed for the service class or category to which he is appointed”

Explanatory Note

(This note is not part of the notification, but is intended to indicate its general purport)

Accounting to General rule 31(a) (ii) of the Kerala State and Subordinate Service Rule no person who does not possess the qualifications if any prescribed for a service class or category shall ordinarily be promoted under clause (i) of the rule and every person who does not possess such qualification and who has been or is promoted under clause(i)shall be replaced as soon as possible by promoting a person possessing such qualifications. But in the case of temporary appointments made under rule 9(a)(i) of the general rules there is no similar stipulations. It is therefore proposed to incorporate a provision in rule9 similar to the above provision. This notification is intended to achieve the above object.
