S.R.O. No. 895/74 – In exercise of the powers conferred 1 by subsection (1) of section 2 of the Kerala Public Service Act, 1968 (19 of 1968) read with section 3 thereof, the Government of Kerala hereby make the following amendments to the Special Rules Published under G.O. (P) No. 464/Public (Rules) Department dated the 28th November 1966 in Part I of the Kerala Gazette No. 49 dated the 13th December 1966, as subsequently amended, namely:-

AMENDMENTS

In the said Rules—

1. In rule 1 --

(a) in category IA after item "Administrative Assistant Office of the Drugs Controller" the following items shall be inserted, namely:-

"Administrative Assistant, Office of the Chief Engineer, Public Health Engineering Department.

Administrative Assistant, Office of the Director, Bureau of Economics and Statistics".

(b) in category 2A--

 (i) for the words "Stationery Department and Registration Department" the following shall be substituted, namely: "Stationery Department Perstant Perstant

"Stationery Department, Panchayat Department and Registration Department".

(ii) after the item "Senior Superintendent, Stationery Department" the following shall be inserted, namely:-

"Senior Superintend, Panchayat Department".

2. In subrule (a) rule 2—

(a) after the item "Administrative Assistant, Office of the Drugs Controller" under category IA and the entries against it under the heading Method of appointment" the following items and entries shall be inserted, namely:-

Administrative Assistant, Office of the Chief Engineer, Public Health Engineering Department Administrative Assistant Office of the

Director, Bureau of Economics and Statistics By promotion from among Senior Superintendents in the Public Health Engineering Department.

(i) By promotion from among Senior Superintendents in the Department.

(ii) In the absence of suitable hands under

item (i) above, by transfer from Publication Assistant in the Kerala Statistics and Economics Service".

(b) after the item "Senior Superintendent, Stationery Department" under category 2A and the entries against it under the heading "Method of appointment" the following item and entries shall be inserted, namely:--

"Senior Superintendent, Panchayat Department

(1) By transfer from among the following posts in the Panchayat Department.

(a) Special Grade Executive Officers.

(b) Panchayat Inspectors, Grade I.

- (c) Junior Superintendents.
- (d) Panchayat Inspectors Grade II.

(2) If no qualified candidate is available under item (1) above recruitment by transfer from the category of Upper Division Clerks employed in the Panchayat Department".

3. In the table under rule 5, for the first two items "Senior Superintendent, Stationery Department" and "Senior Superintendents" under category 2A in column (1) and the entries against them in columns (2) and (3) the following items and entries shall be inserted, namely:-

"2A. Senior Superintendents

(Other than in the Land Revenue, Agriculture Income tax and Sales tax, Civil Supplies and Excise Branches f the Board of Revenue Stamp Manufactory Department, Hindu Religious and Charitable Endowment Department, Weights and Measures Department, Harijan Welfare Department and Registration Department).

- By transfer 1.S.S.L.C. or equivalent qualification
 - 2. Pass in Account Test (Lower) or the Account Test for Executive Officers".

Note:- The amendments in respect of Senior Superintendent, Panchayat Department shall be demand to have come into force with effect from 28-11-1966.

Explanatory Note

(This note is not part of the notification but is intended to indicate its general Purport.)

Government have decided to prescribe method of appointment for the post of Administrative Assistant, Office of the Chief Engineer, Public Health Engineering Department and Administrative Assistant. Office of the Director, Bureau of Economic and Statistics by amending the Special Rules for the Kerala General Service issued in G.O, m(P) No. 464/PD dated 28-11-1966, Government have also decided to revise the

method of appointment to the post of Senior Superintendent, Panchayat Department by adding certain other posts also in the Department as feeder categories and to prescribe specific qualification for the posts of Senior Superintends in the various Department by amending the Special Rules for the Kerala General Service. This notification is intended to achieve the above object.
