S.R.O No.1154/77- In exercise of the powers conferred by subsection (1) of section 2 of the kerala public service Act1968 (19 of 1968) read with section 3 thereof the government of kerala hereby make the following amendments to the kerala state and subordinate services Rules, 1958, namely:-

AMENDMENTS

In part II of the said rules in sub-rule(a) of rule 18 and sub-rule (e) of rule 31, the sentence beginning with the words "He shall also be eligible to draw increments" and ending with the words 'unless otherwise ordered by the state government shall be omitted.

The amendment hereby made shall be deemed to have come into force with effect on and from the 24th July 1967.

Explanatory Note

(This is not part of the notification but is intended to indicate its general purport)

According to G.O.(P)No 301/67/Fin. Dated 24-7-1967, service on temporary appointment/promotion followed by regular appointment in the same post can be counted increment. However under the provisions of General Rules18(a) and 31(e)of the Kerala state and subordinate period of temporary appointment / promotion the eligibility to draw increments in the time scale of pay arise only from the date of commencement of probation. To remove the obvious inconsistency between the above G.O and the Rules it is proposed to amend the general rules by deleting the offending provisions there in with effect from the date of the above G.O. this notification is intended to achieve the above object.
