NOTIFICATION

S R O No 207/80- In exercise of the powers conferred by subsection (1) section 2 of the kerala public services act 1968 (19 of 1968) read with section 3 thereof the Government pf kerala hereby make the following amendment to the kerala government servants, Application for posts (Private Employment and government services) Rules 1958, namely;-

AMENDMENT

1. Short title and commencement- (i) These rules may be called the kerala government servants' application for posts (Private Employment and Government Services) Amendment Rules 1980.
(ii) They shall come into force at once.
2. Amendment of rule 2. In rule 2 of the Kerala Government Servants Application for posts (private Employment and Government Service) Rules 1958, for clause (b) of sub rules (2) the following shall be substituted namely;-

“ (b) Applications for a post or for transfer to a post under another state Government or the Government of India by a Government servant shall be submitted through the head of office in which he is working at the time of making the application;

Provided that a Government servant who wishes to appear at a competitive examination conducted by the union public services commission or wishes to apply for a posts, recruitment to which is proposed to be made by selection through the union public service commission may submit the completed application in the prescribed form direct to the commission. He should however immediately inform the Head of his office giving details of the examination/post for which he applied requesting the latter to communicate his permission to the

commission directly. In case the Head of office considers it necessary to withhold the requisite permission he should inform the commission within 30days of the closing date for the receipt of the applications. In case no such communication is received from the head of office it shall be presumed by the commission that there is no objection on the part of the employing department to the candidature of the applicant to be considered by the commission”

Explanatory Note

(This note is not part of the amendment but is intended to indicate its general purport.)

The Government of India Ministry of Home Affairs Department of personnel and Administrative Reforms have in their office memorandum No.42015/4/78-East (C)dated 1-1-1979 prescribed a revised procedure for forwarding applications to the union public service commission from candidate serving under that Government ; it is considered necessary to amend the kerala Government Servants Application for posts (private Employment and government Services) Rules 1958 on the lines of the revised procedure adopted by the central Government. This notification is intended to achieve the above object.
