S.R.O.No699/78- In exercise of the powers conferred by subsection (1) of section 2 of the kerala public services Act 1968(19 of 1968) read with section 3 of the Government of kerala hereby make the following amendments to the kerala state and subordinate services rules, 1958, namely;-

AMENDMENT

In part I of the said rules, in list III of the schedule,-

- (1) after the heading "Other Backward Classes in the Kerala State" the following Sub heading shall be inserted, namely;-  
"1.Throughout the state";
- (2) Under the sub heading so inserted-
  - a) items 4,5,47,49,and 68 shall be omitted;
  - b) after the item "15 Devanga", the following item shall be inserted, namely;-  
"15A. Dheevera (Arayas, Arayavathis, Mukkuvan or Mukaya, Mogaveera and Valans"
