NOTIFICATION

S R O No 11909/87- in exercise of the powers conferred by subsection (1) of section 2 of the kerala public service Act 1968 (19 of 1968), read with subsection 3 thereof the Government of kerala hereby make the following amendment to the special rules for the kerala general service published under notification G O (P) No.464 dated the 28th November 1966 of the public (Rules) department in Part I of the kerala Gazette No. 49 dated the 13th December 1966 as subsequently amended, namely;-

AMENDMENT

In the said Special Rules in sub rule (b) of rule 7 before the provisions thereto the following shall be inserted namely;

"During the period of probation he shall be given the minimum of the scale of pay of Divisional Accountant Plus usual allowance admissible. A person selected form any other service of the state shall continue to draw the pay and allowance which he would have drawn but for his selection subject to the minimum of the scale fixation of pay under rule 28A of the kerala service rules shall be allowed to persons appointed from any other service but no refixation of pay shall be allowed."

2. The above amendment shall be deemed to have come into force with effect on and form the 8th day of January, 1974.

Explanatory Note

(This note does note form part of the notification but is intended to indicate its general purport.)

In the Special Rules for the Kerala General Service there is specific provision regarding the training allowance to be given to Divisional Accountants. But there is no mention about the pay and allowance to be paid during the period of probation. This adversely affected those who were in service before there recruitment and were drawing a higher pay. To make them eligible to draw the pay and allowance which they would have drawn in the previous post Government propose to amend the Special Rules form 8-1-1974. This notification is intended to achieve the above object.
