According to the orders issued in the G.O. read above, certain limits were fixed for remittance of balance value exceeding Rs.20,000/- in installments within the grace period of 52 days. Timber fully paid for as per each such installment could also be removed within the grace period. Amounts pending remittance after the grace period were to be remitted in one lump with penal interest, ground rent etc. as per rules and no part removals would be allowed after this period.

The Chief Conservator of Forests has requested for further liberalization of the above orders so as to afford more facility to the purchasers to remit the balance value in instalments. Government are pleased to accept the recommendation of the Chief Conservator of Forests as shown hereunder:

In cases in which balance value is above The purchaser will be allowed to remit it in Rs.20,000/- but below Rs.40,000/- two instalments

Do. Balance value is above Rs.40,000/- but below Rs.60,000/
Do.above Rs.60,000/- but below In four instalments

Rs.80,000/Do.above Rs.80,000/- but below In five instalments and no on Rs.1.00.000/-

But in such cases, an additional security of Rs.3,500/- over and above the usual initial deposit of a similar amount will also be realized, which together with the initial deposit will be adjusted only towards the last instalments of remittance. It is further ordered that part removals in those cases will also be allowed after the grace period, according to the value permitted. Other conditions regarding levy of penal interest after the grace period, ground rent, surcharge etc. and procedure for resale will remain unchanged.
