Sub:- Harijan Welfare-housing scheme for scheduled Tribes – supply of timber at seigniorage rate – authorization – orders request for

I invite kind attention of Government to the G.O. cited in which Government have ordered that the wind fallen trees or trees standing in the settlement other than teak and rosewood will be measured over to the respective tribes at seignior age rates for house construction purposes so as to overcome the difficulties which the schedules tribes are being experienced.

It has been represented by the Scheduled tribes to whom house construction grants were sanctioned from this department that the Range Officers/Divl. Forest Officers are raising objections that has timber cannot sold by them since they have not been delegated with powers to do so. If the officers of the forest department are not empowered to sell the timber to such persons at seigniorage rate, the progress of constructions will be affected adversely.

I therefore recommend that Range Officers of the Forest Department may be delegated with powers to sanction the timber worth R,150/- and below and the Divl. Forest Officers to sanction the timber worth above Rs.150 and below Rs.500 to a tribal family at a time at seigniorage rates, for bonafide purpose of construction of houses in the forests.

I request the favour of very early orders.
