TRAVELLING ALLOWANCE-TOUR OF OFFICERS OUTSIDE THE STAE ACCOMMODATION IN PRIVATE HOTELS AND GUEST HOUSES-REIMBURSEMENT OF ROOM RENT-REVISIN AND FIXATION OF RATES AMONG DIFFERENT GRADES OF OFFICERS-ORDERS ISSUED

ORDER

In the G.O read, Government revised the rates of room rent reimbursable to Government Officers when they stay in private hotels outside the State while on official tour and the revised rates have been fixed as follows:-

(i)	New Delhi, Bombay and Calcutta	Actural rent paid subject to a maximum of Rs. 140 a day, on condition that for Stay in New Delhi the reimbursement will be admissible only if accomodation is not
(ii)	State Capitals other than New Delhi, Bombay and	available in Kerala House Actual rent paid subject to a maximum of Rs. 50 a day

But No distinction has been made between the different grads of officers for claiming the amount. This has resulted in the maximum amount being claimed by all grades of officers, by seeking accommodation in costlier hotels. Therefore it has become necessary to introduce a graded system for reimbursement of room rent to officers touring outside the State.

- 2. Different rates of mileage allowance and daily allowance are granted to different grades of officers. It is therefore felt that it would be quite reasonable to fix different rates according to the grades of officers for the purpose of reimbursement of room rent also.
- 3. The existing rates of reimbursement of room rent are Rs. 140 a day for Delhi, Bombay and Calcutta and Rs. 50 a day for other State Capitals. The levels of room rent in the four major cities of Delhi, Bombay, Calcutta and Madras are about the same. Hence it has been decided that Madras may also be included in the same category as Delhi, Bombay and Calcutta.
- 4. Accordingly Government are pleased to revise the rates of reimbursement of room rent as follows:-

- 5. The officers can draw daily allowance they are eligible for under the rules in addition to room rent at the rates specified above
- 6. In New Delhi the reimbursement is admissible only if accommodation is not available in Kerala House.
