ORDER

- I) In the Government Orders read as first and second papers above orders were issued for rent recovery at the rate of 4% of basic pay from the All India Service Officers occupying Government quarters.
- 2) Government of India, vide its Office Memorandum cited as third paper above have modified the practice of rent recovery by limiting it to a license fee applicable for Central Government Residential accommodation throughout the country.
- 3) This issue was brought to the notice of Government and Government so hereby order that the rate of rent to the All India Service Officers occupying Government quarters will be the same rate of licence fee applicable to Central Government Residential accommodation according to the type of accommodation as specified in the Office Memorandum read as third paper above.
- 4) A copy of the existing rate is enclosed here as Annex.I to this Government Order. This order will have prospective effect only.
