ORDER

In the G.O. read as first paper above the Upper Division Typists of the various Department of Government were grouped into the following four units for the purpose of their promotion to the post of Selection Grade Typist.

- I. Secretariat Unit
- II. High Court Unit
- III. Subordinate Courts Unit
- IV. Board of Revenue Unit

2. In the G.O. read as second paper above it was ordered in modification of the G.O. read as first paper, that the office of the Public Service Commission and the Administrative Secretariat would be taken out of the General Secretariat Pool and that they should form two individual units. In the Memo read as third paper, the above order was kept in abeyance until further orders pending a decision on the representation submitted by the Kerala Secretariat N.G.O. Association requesting reconsideration of the orders issued in the G.O. read second paper.

After considering the representations submitted by the Kerala Secretariat N.G.O. Association and after hearing the points of view of the representatives of the typists in the various department of the Secretariat Unit, Government are pleased to issue the following orders, in modification of the N.G.Os read above:-

1. The Secretariat Unit of Typists consisting of the Departments given below constituted in the G.O. read as first paper will be abolished. The typists of the Administrative secretariat and the Governor's secretariat will constitute a single Unit. Typists of all departments other than the administrative secretariat and the Governor's secretariat will have their own separate seniority for purpose of promotion to higher grades.

- I. Administrative Secretariat
- II. Finance Department
- III. Law Department
- IV. Governor's Secretariat
- V. Office of the Kerala Public Service Commission
- VI. Office of the Kerala of Local Fund Accounts
- VII. Office of the Advocate General
- VIII. Office of the State Achieves

2. The Law Department is entitled only 5 Senior Grade posts according to the Strength of Typists in that Department. But they have at present 8 such posts in the pool. The excess posts of Senior Grade Typists in the Law Department will be protected till they are vacated by the incumbents concerned either by retirement or otherwise.
