## **ORDER**

In the G.O.s.2<sup>nd</sup>, 3<sup>rd</sup>, 4<sup>th</sup>, 5<sup>th</sup> and 7<sup>th</sup> read above Government accorded sanction for the following persons to the Kerala Research Institute:

- 1) Sri. P. Viswanathan, Manager, Administrative Secretary.
- 2) Sri. J.Sukumaran, U.D.Clerk, as Accounts Assistance-cum-clerk.
- 3) Sri. P.K. Padmanabhan, U.D. Clerk as Accounts Asst.-cum Clerk.
- 4) Sri.C.V.Jose, Stenographer as Stenographer.
  - 2) The terms and conditions governing their deputation will be as follows:
- 1) The term of deputation will be a period of 6 months for Sri.Sukumaran, one year for Sri. P.K.Padmanabhan and 11/2 years for other two persons from the dates of relief from the Forest Department.
- 2) The officers will be paid by the foreign employer a deputation allowance at the rate of 20 % of their grade pay in the parent department from time to time.
- 3) They will be eligible for T.A at the rate of the Institute if the rules are not less advantages from those under the State Government.
- 4) Joining time will be regulated as provided in the K.S.R and joining time pay and T.A both for taking up the appointment in the Institute and reversion there from will be met by the foreign employer.
- 5) They will be eligible for medical benefits on a scale not less favorable than that under the State Government.
- 6) Leave Salary in respect of disability leave if any granted to them on account of disability sustained in and through foreign service will be met by the the State Government.
- 7) The whole expenditure in respect of compensatory allowance, if any for periods of leave in or at the end of deputation will be met by the –foreign employer.

- 8) The difference between the amount of leave salary that would have been admissible of them had they remained in Government service and the amount of leave salary calculated on the pay drawn during deputation is recoverable from the foreign employer.
- 9) The foreign employer will remit pension and leave salary contribution regularly at 1/6 and 1/12 respectively of their pay from time to time plus dearness pay in the Government service.
- 10) In respect of other matter, the terms and conditions will be regulated by the provision in chapter XI of K.S.R PartI.
