## ORDER

The Principal Chief Conservator of Forests in his letter read above has furnished a proposal to Government for regularisation of 1116 posts of Forest Department, which were created during the period from 1981 to 2000. These posts were regarded as temporary when they were originally created though the nature of duties and functions attached to the posts was permanent. Year after year continuance sanction was being given to these posts by Government. As per the Government Order read as 2<sup>nd</sup> paper above, posts which were in existence for a minimum period of five years will be treated as permanent posts.

2. The above posts were created at different periods in the Social Forestry Wing, Wildlife Wing, Research and Working Plan Wing, Vigilance Wing, Sales Divisions and Territorial Divisions of the Forest Department. The objective behind the creation of the posts was ensuring effective functioning of the various projects and programmes of the Government. Since the duties and functions attached to the posts have to necessarily continue in the department, it has become necessary to regularise the posts.

3. Government have examined the proposal in detail and are pleased to regularise 1113 posts created in the Forest Department as per Government orders which are appended as annexure A, B, and C, excluding the three posts of Part Time Sweepers temporarily created as per G. O. (Ms).84/84/AD dated 25.10.1984.
