### ORDER

In the Government Order first read above, Rule 4 of the Kerala State and Subordinate Service Rules, 1958 was amended to provide that a candidate who is an ex-serviceman released on completion of his “normal tenure of service” from the Defence Forces may apply for appointment to posts in the subordinate services in a form with only one-fourth the amount of the prescribed fee embossed thereon. In the Government Orders second and third read above this concession was extended to those personnel for applying to posts in the Government owned Companies and Corporations carrying a scale of pay, the minimum of which is less than Rs. 500. in the Government Order fourth cited, the expression ‘normal tenure of service’ has also been defined.

The Kerala Public Service Commission in their letter read above have advised that the benefit of the above concession may be restricted to all ex-servicemen who are in receipt of pensionary benefits or are eligible for pensionary benefits for their military service.

Governments are pleased to accept the above advice of the Public Service Commission and they order accordingly. The Government Orders read as second, third and fourth papers above stand modified to the above extent.

The candidates while sending applications to the Public Service Commission will produce Pension Payment Orders to prove that they have been retire with pensionary benefits if this fact is not clear from their discharge certificates.
