### **ORDER**

In the G.O reads as Ist paper, Government have issued orders to the effect that all Certificates and Diplomas awarded by the Boards of Secondary and Intermediate Education duty set up and recognized by the Central Government or a State Government should automatically be recognized for the purpose appointment to posts in public service in the State. In their letter read as 2<sup>nd</sup> paper above, the government of Andhra Pradesh have informed that they had recognized a pass in S.S.L.C of Kerala State as equivalent to minimum General Educational qualification specified in the schedule to the general rules for purpose of recruitment to State and Subordinate Services and have proposed that the pass in S.S.L.C (Compartmental) Examination of Kerala State may be recognized as equivalent to the minimum general educational qualification of that State for entry in public services on a reciprocal basis. The Commissioner of Government Examinations and the Kerala Public Service Commission have agreed to the above proposal. The Kerala Public Service Commission has also advised that while recognizing the compartmental pass of the S.S.C. examination of the Andhra Pradesh s equivalent to the certificate issued by the Government of Kerala the minimum marks fixed for each subject for a pass under the compartmental system do not contain the endorsement of "eligibility of public services".

2. In the circumstances the Government are pleased to order that the Compartmental pass in S.S.C Examination of the Government of Andhra Pradesh with the following marks under the academic and bifurcated courses will be considered as equivalent to a pass in S.S.L.C (Compartmental) examination of the Government of Kerala for purpose of appointment to public services in the State.

(i) Candidates offering academic courses

First Language	35% of marks
Second Language	20% of marks
Third Language (English)	35% of marks
Mathematics	35% of marks
General Science	35% of marks
Social Studies	35% of marks

(ii) Candidate offering bifurcated Courses.
First Language 35% of marks
Second Language 20% of marks
Third Language (English) 35% of marks
Prescribed combination subjects
Bifurcated course (numbering) 35% of marks in each subjects.
